SUBJECT: Accelerated Step in Pay

Background Information:

The Berkeley Unified School District has had a lot of difficulty in hiring and retaining Interpreters for the Deaf. Over the years, the District has contracted with an outside agency to provide sign language interpreters. Job announcements have been posted in Edjoin, Craigslist, and the District's work sites. After multiple job announcements and years of search, we have four qualified candidates who have met the requirements to be placed on an eligibility list.

The Special Education Department is asking the Personnel Commission to permit the District to hire these candidates at step 5. These persons would like to come and work for Berkeley Unified School District but can not afford to accept the job offer at step 1. When the District contracts with an outside agency to provide the mandated interpreting services, the District pays about \$100.00 an hour. Hiring these individuals at Step 5, the District will pay \$24.39 an hour. This action will allow the District to save scarce economic resources.

The Personnel Commission when granting accelerated steps has asked the following two questions: 1) Has the District had a difficult time recruiting quality qualified applicants? 2) Has the District had difficulty retaining employees? The record indicates that it has been very difficult recruiting and retaining qualified applicants for the Interpreter for the Deaf positions.

Personnel Commission Rule/Education Code:

Difficulty in recruiting and retaining Interpreters for the Deaf

Staff Recommendation:

Staff recommends the Personnel Commission grant an accelerated step (step 5) for Interpreters for the Deaf.

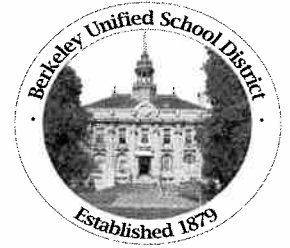
