President Rivera said this is a safety issue. He said we need to convey the message that we are not installing the cameras to monitor the students, we are installing cameras to make the students safer in the school. We want to make sure that Berkeley High School is a safe place—that we deter any type of activity that would be detrimental to the students.

Board members wanted to know if there will be cameras to monitor the rest rooms.

The Board requested that the Superintendent submit a proposed Board policy regarding this item at the next Board meeting.
