25. <u>Approval of Plan to Balance the FY 2001-2002 General Fund Budget—Meeting the Challenge</u>

The Board had before it a 17-page document, "Meeting the Challenge—Balancing the 2001-2002 General Fund Budget."

Interim Superintendent Goldstone recommended that the Board adopt the plan to balance the 2001-2002 General Fund Budget in Scenario 2, as modified, on page 6 of the 17-page document.

That the superintendent be directed to implement his recommendations with the following exceptions:

- Do not reduce Longfellow 7th period (1.2 FTE=\$72,500).
- Provide staffing to achieve class sizes of 20:1 in grades K-3; 26:1 in grades 4-5; 28:1 in grades 6-8; and 29:1 in grades 9-12. In addition, the high school enrichment add-on should be reduced by 3 FTE. In essence, this is model E modified by the reduction of 3 FTE's from the high school enrichment and the addition of 2 FTE at 7th-8th, and 1 FTE at 6th, resulting in an increased cost of \$174,226. In combination, these two changes total \$246,726.

Motion: Directors Schultz/Rivera and approved unanimously on voice vote:

That the Superintendent be directed to provide a list identifying an additional \$229,976 of other sources or cuts which might be implemented to further reduce class size for FY 02. This would allow the District to implement model G, which is the class size model

implemented for the current year.
